IMPORTANT NOTICE

WORKERS' COMPENSATION LAW IN THE STATE OF ARKANSAS PERMITS AN EMPLOYER TO PURCHASE WORKERS' COMPENSATION INSURANCE WITH A DEDUCTIBLE APPLICABLE TO MEDICAL AND INDEMNITY BENEFITS. THE DEDUCTIBLE APPLIES SEPARATELY TO EACH CLAIM FOR BODILY INJURY BY ACCIDENT OR DISEASE, REGARDLESS OF THE NUMBER OF PEOPLE WHO SUSTAIN INJURY BY SUCH CLAIM.

PLEASE CHECK THE OPTION WHICH YOU HAVE ELECTED AND RETURN THIS FORM TO THE COMPANY AS SOON AS POSSIBLE.
